#### BACKGROUND

- They principally engage in the provision of thermal imaging products and services, self-stabilised imaging products and services, and general aviation products and services in the PRC and Hong Kong.
- Their headquarters is in Hong Kong and they have six sales offices in different provinces and municipalities in the PRC.
- They market their products and services under brands "Peiport", "PTi", "SkyEye", "SeaVision" and "PGs".
- Their customers typically require them to provide their products tailored to their needs, and they provide the corresponding products and services using equipment and components sourced from third party suppliers and/or fabricated by them.
- Some of their products are customised according to their customers' specifications, such as weight, model, type and usage under specified environment. For instance, their unmanned substation infrared monitoring system to be used outdoor will be equipped with waterproof and dust-proof shell, and a ceiling with better design and stronger materials to withstand exposure to sunshine, wind, dust and rain. Similarly, they will adopt special materials and design in their unmanned substation infrared monitoring systems to be used in electricity substation in order to ensure their abilities to resist the interference created in the course of electricity transmission.
- They also provide training to their customers on how to use both the hardware and software of their products, as well as warranty and after-sales technical support.

## **BUSINESS STRATEGY AND FUTURE PLANS**

- Establishing new research and development centres in the PRC and Hong Kong to keep themselves abreast of technological changes in the industry.
- Enhancing the recognition and qualification of their products by obtaining internationallyrecognised certificates.
- Strengthening their sales capacity and capturing new sales opportunities through increasing their participation in industry exhibition, trade fairs and conventions and number of demonstration units as well as recruitment of additional sales and marketing personnel.
