- 客戶必須要申請港股串流報價,方可申請上海A股串流報價服務。
 Clients must apply for Hong Kong Stocks Real-time Streaming Service in order to apply for the Shanghai A-Share Real-time Streaming Service.
- ^{2.} 港股串流報價月費為 338 港元, 上海 A 股串流報價服務月費為 380 港元, 即申請上海 A 股串流報價的收費合共 718 港元。 Hong Kong Stocks Real-time Streaming Service costs HKD 338 per month.
