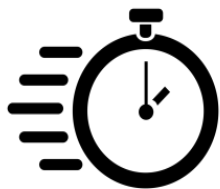
Electronic Direct Debit Authorization (eDDA) is a value-added service of the “Faster Payment System” (FPS) launched by the Hong Kong Monetary Authority. You can apply for eDDA service via UTRADE HK mobile app. After completing your application, you can initiate a deposit instruction via UTRADE HK mobile app and the authorized bank will deposit funds into your Equities account.

Features of eDDA Service:

	Authorization via UTRADE
Support platform	Register and deposit via UTRADE HK mobile app
Eligible account	Individual Equities online account
Set up time	Immediately (usually will effect within 5 business days)*
Deposit time	Immediately (usually will effect within 15 minutes)*
Support banks	17 major local banks
Support Currencies	HKD and CNY
Deposit Slip	Not Required
Handling Fees	No

*Subject to the processing time of the authorized bank



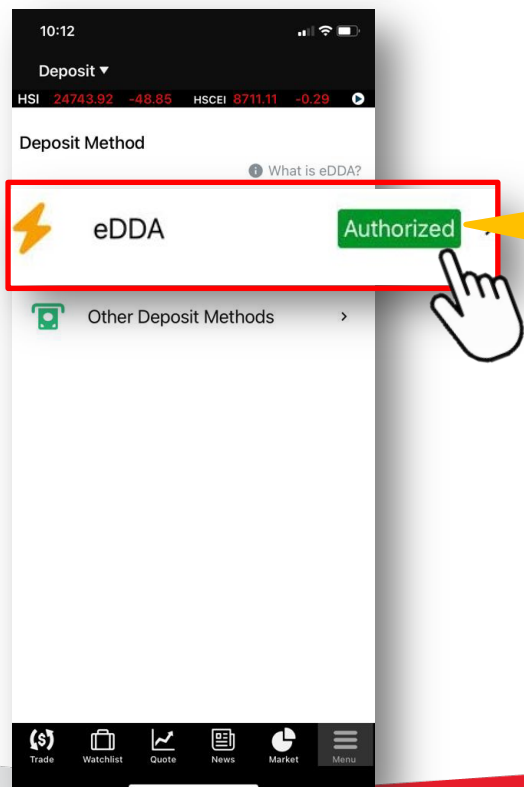
User Guide - Deposit

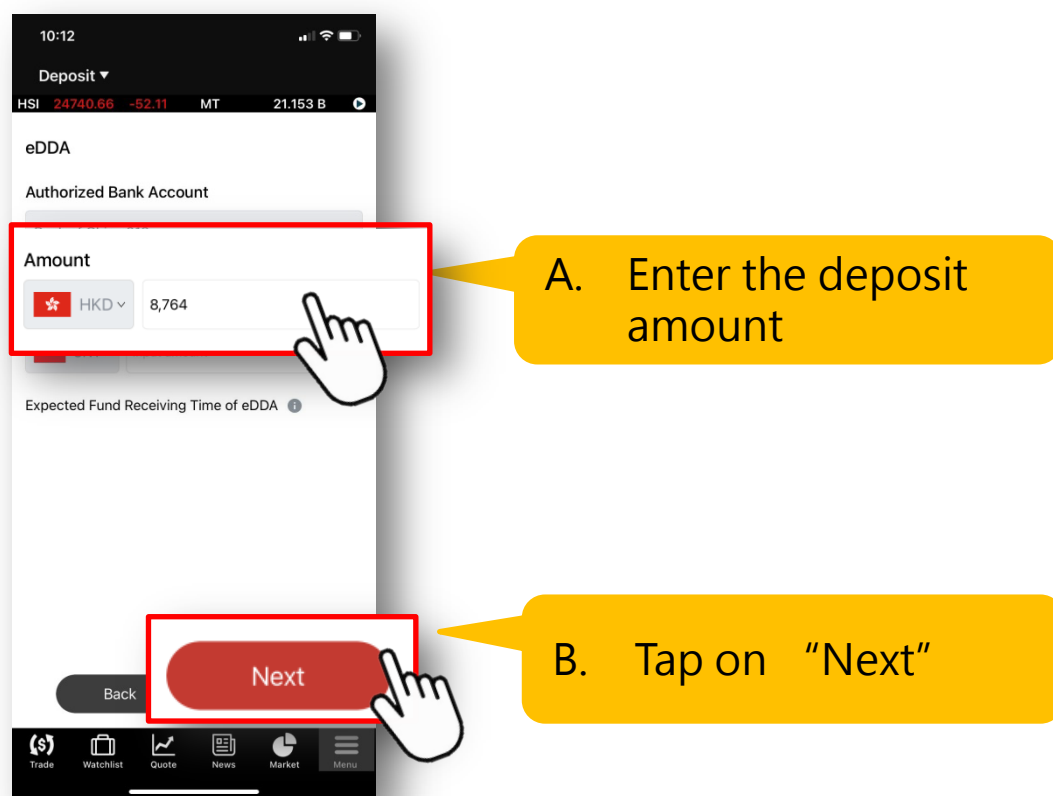


When the status shows **"Authorized"**, you can submit the deposit instruction via eDDA

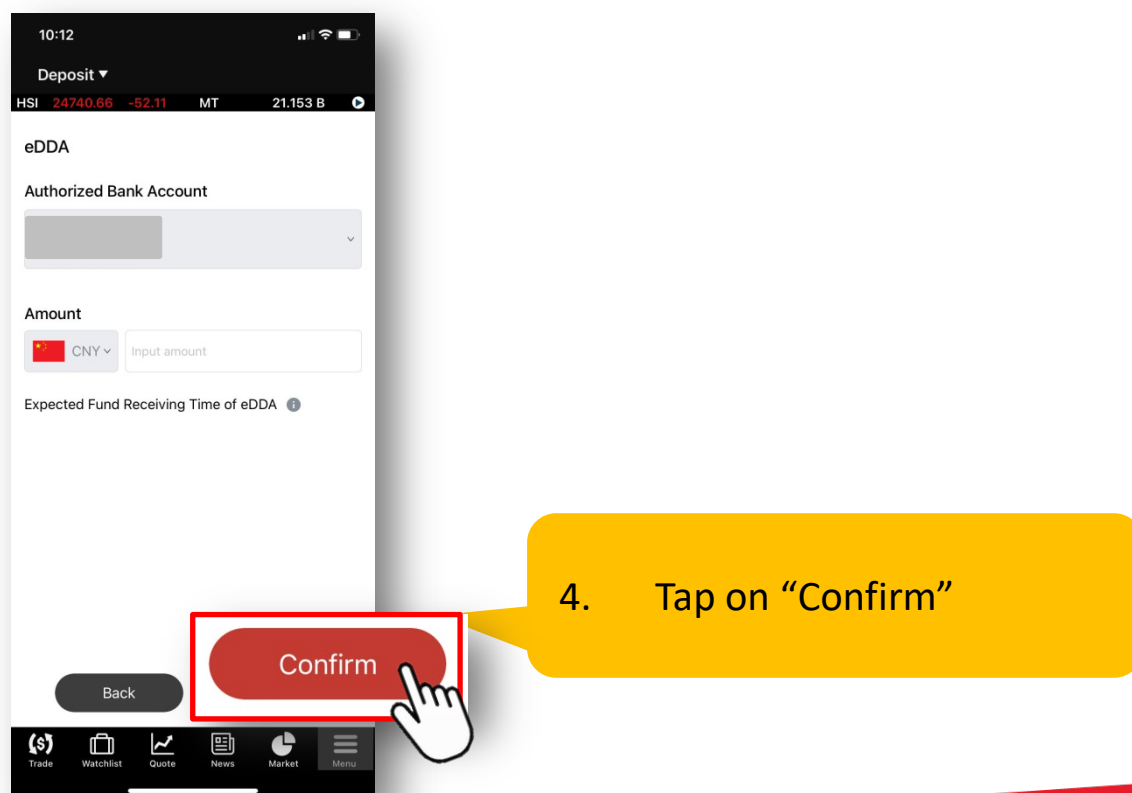

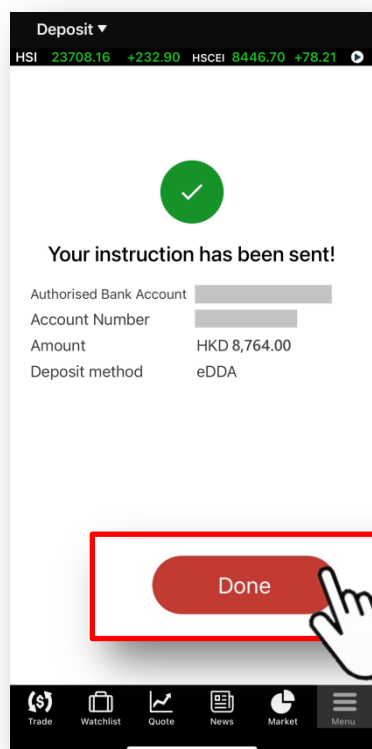

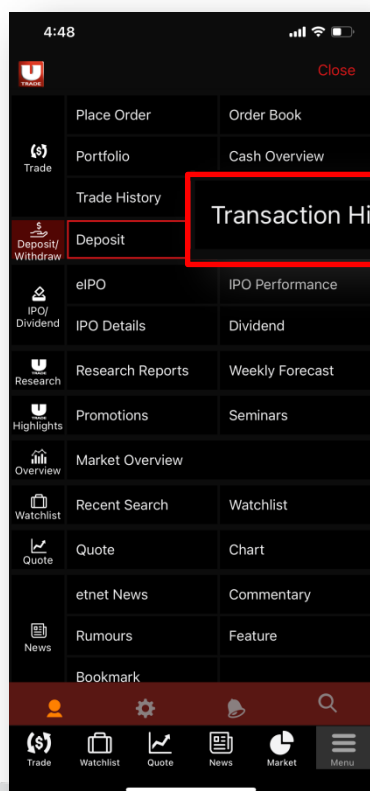

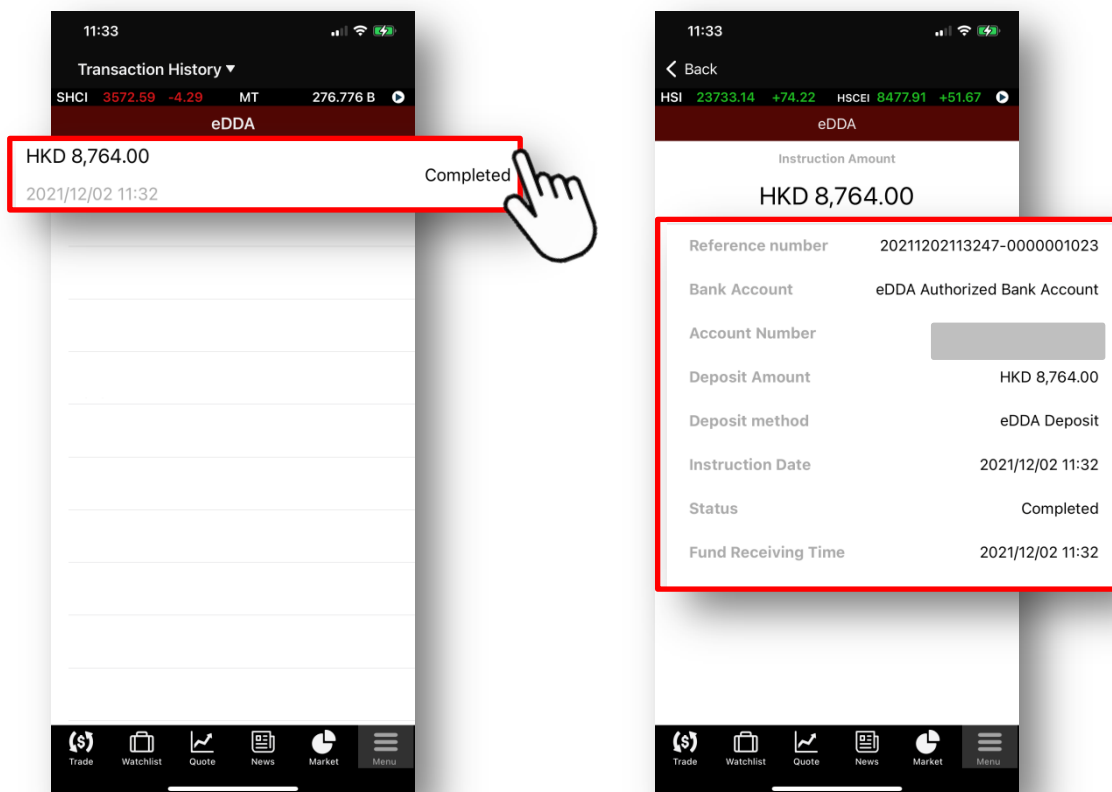
