「月供股票計劃」(「計劃」)-條款及細則

Monthly Stock Savings Plan ("The Plan") - Terms and Conditions

- 1. Minimum monthly contribution amount is HKD 1,000 per stock, incremental contribution for the same stock must be in multiples of HK\$500. 每隻股票每月最低供款金額為港幣1,000元,遞增供款金額必需為港幣500元之倍數。
- 2. Contribution day of the Plan is on the tenth day of each month. If such day is a non-HKEX trading day, contribution day will fall on the next HKEX trading day. 「計劃」的供款日為每月十號。若當日為非香港交易所交易日,供款日將順延至下個香港交易所交易日。
- 3. Client should ensure there is sufficient available fund in the Plan account to be paid for the monthly contributions in full in respect of all the portfolios comprised in the Plan account on the contribution day. - 9. The purchase price of a stock is the average price of the securities purchased by the Company on behalf of clients after consolidating clients' contribution amounts. 股票購入價是指在合併所有客戶的供款金額後,公司代客戶購買的股票之平均價。
- 10. The Company shall be entitled to terminate the Monthly Stock Savings Plan immediately at any time if: 公司有權在任何時間即時終止「月供股票計劃」如果:

- 11. In the event that trading of the selected stock is suspended or stock purchase cannot be executed due to market conditions, the Company will try to purchase the stock on the next trading day.
